#### 1. PROBLEM STATEMENT

### Describe the city, county, or jurisdiction this grant will impact.

The City of Manteca, is situated in the southern portion of San Joaquin County, spans approximately 22.98 square miles and has a population around 83,498 (2020 Census). In recent years, Manteca has faced challenges related to crashes primarily propelled by the top five Primary Crash Factors (PCF): Driving under the influence of alcohol and/or drugs, unsafe speed, auto right-of-way violations, stop light/sign violations, and improper turning movements. The City of Manteca has witnessed a higher number of individuals suffering injuries due to these crashes compared to the overall crash count. Operations associated with grant funding will be directed to roadways within the enforcement and operational control of the Manteca Police Department.

# Describe the problem(s) to be addressed, supported by current and relevant crash data. (most recent calendar year data/stats).

Manteca Police Department is committed to reducing traffic crashes and prioritizing the safety of its residents by addressing key issues such as unsafe speed, impaired driving and nighttime crashes. Unsafe vehicle speed remains the top contributing factor to both fatal and injury crashes in Manteca, with a clear correlation between higher speeds and the severity of injuries or fatalities. Additionally, impaired driving caused by alcohol, drugs, or both, continues to pose a significant threat to public safety. These problems highlight the critical need for directed enforcement to deter dangerous driving behaviors and reduce crashes.

The department recognizes the importance of proactive measures, such as Saturated and Directed DUI enforcement, to combat impaired driving. However, limited department funding for such operations hinders the ability to address this issue effectively without external support. Past grant-funded initiatives have proven essential in implementing successful countermeasures and continued funding will allow the department to deploy additional officers to areas with increased crash rates, ensuring strategic enforcement of unsafe speed, impaired driving and other moving traffic violations.

Speed remains to be the top primary crash factor for injury crashes (139) and fatal crashes (2) in 2024, followed by a distant second of Improper Turning (1 fatal, 54 injury), and Driving Under the Influence (1 fatal, 45 injury) being a close third. By reducing a driver's speed, it would also reduce other types of crash factors since drivers would obtain additional stopping distances and additional time to react to hazards, thus avoid crashes. Studies have shown that radar speed signs have been a significant assistance in reducing speeds throughout the streets. Use of a radar speed sign will provide the ability to collect speed data along various streets to best determine the occurrence and times of violations. By having radar trailer, we will be able to easily place the trailer in various locations in a strategic and methodical manner.

Beyond enforcement, the department will use education as a key strategy to promote safe driving practices. Outreach efforts will include press releases, social media campaigns and printed materials to educate the public on the dangers of speeding and impaired driving. School visits will focus on teaching youth about bicycle and pedestrian safety and raising awareness among teen drivers about the risks of distracted driving. While seat belt compliance throughout the State of California has improved, Manteca Police Department aims for 100% usage through targeted education and enforcement. With support from California Office of Traffic Safety grant funds, the Manteca Police Department will address unsafe driving behaviors more effectively, reducing crashes and mitigate the physical, emotional and financial impacts these incidents have on the community.

### Define the target population the grant intends to serve and how they are affected by the problem(s).

The target population for the initiatives outlined in this problem statement includes the residents, visitors, and commuters within the City of Manteca, with a specific focus on vulnerable groups such as pedestrians, bicyclists and teen drivers. This population is directly affected by the problems of unsafe driving behaviors, including speeding, impaired driving and distracted driving which contribute to a higher risk of traffic crashes, injuries and fatalities.

Residents and commuters traveling through Manteca are at an increased risk of being involved in or impacted by traffic crashes caused by the top Primary Crash Factors (PCFs). Vulnerable groups (previously

mentioned) face greater risks due to unsafe speeds and impaired driving, which reduce reaction times and increase the likelihood of severe injuries. Teen drivers, who may lack experience or awareness of the dangers of distracted and impaired driving are also a key population impacted by these issues. Families with young children are affected when unsafe practices, such as speeding and improper use of child safety seats result in preventable injuries or fatalities. By addressing these issues through targeted enforcement and education efforts, the Manteca Police Department aims to increase roadway safety within Manteca, while promoting a culture of traffic safety for all involved.

#### 3. METHOD OF PROCEDURE

### A. Phase 1 – Program Preparation (1st Quarter of Grant Year)

- The department will develop operational plans to implement the "best practice" strategies outlined in the objectives section.
- Conduct all training needed to implement the program, in the first quarter.
- Purchase all grant related supplies and materials to implement the program, in the first quarter.
- Items with a unit cost of \$5,000 more (including tax and shipping) must comply with Buy America.
- In order to develop/maintain the "DUI BOLOs," research will be conducted to identify the "worst of the worst" repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The DUI BOLO may include the driver's name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. DUI BOLOs should be updated and distributed to traffic and patrol officers at least monthly.
- Implementation of the STEP grant activities will be accomplished by deploying personnel at high crash locations.

#### Media Requirements

Issue a news release approved by the OTS PIO announcing the kick-off of the grant by December 31 and after the grant is signed and executed, but no sooner than October 1, the start of the grant year. The kick-off release must be approved by the OTS PIO. If you are unable to meet the December 31 deadline to issue a kick-off press release, communicate reasons to your OTS grant coordinator and OTS PIO.

### B. Phase 2 – Program Operations (Throughout Grant Year)

#### Media Requirements

- Social media posts highlighting state or national traffic safety campaigns (Distracted Driving Month, Motorcycle Safety Awareness Month, etc.), enforcement operations (DUI checkpoints, etc.), or any other grant-related activity such as Bicycle rodeos, presentations, or events, are highly encouraged but do not require prior approval.
- Submit a draft or rough-cut of all digital, printed, recorded or video material (brochures, posters, scripts, artwork, trailer graphics, digital graphics, social posts connected to an earned or paid media campaign grant objective) to the OTS PIO at <a href="mailto:pio@ots.ca.gov">pio@ots.ca.gov</a> and copy your OTS grant coordinator for approval prior to the production or duplication.
- Use the following standard language in all press, media, and printed materials, space permitting: Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
- Space permitting, include the OTS logo on all grant-funded print materials, graphics and paid or earned social media campaign grant objective; consult the OTS PIO and copy your OTS grant coordinator for specifics, format-appropriate logos, or if space does not permit the use of the OTS logo.
- Email the OTS PIO at <a href="mailto:pio@ots.ca.gov">pio@ots.ca.gov</a> and copy your OTS grant coordinator at least 21 days in advance, or when first confirmed, a short description of any significant grant-related traffic safety event or program, particularly events that are highly publicized beforehand with anticipated media coverage so OTS has sufficient notice to arrange for attendance and/or participation in the event. If unable to attend, email the OTS PIO and coordinator brief highlights and/or results, including any media coverage (broadcast, digital, print) of event within 7 days following significant grant-related event or program. Media and program highlights are to be reflected in QPRs.
- Any news releases, work plans, scripts, storyboards, artwork, graphics, videos or any educational
  or informational materials that received OTS PIO approval in a prior grant year needs to be
  resubmitted for approval in the current grant year.
- For additional guidance, refer to the <u>OTS Grants Materials Approval Process Guidelines</u> and OTS Grants Media Approval Process FAQs on the OTS website.
- Contact the OTS PIO or your OTS grant coordinator for consultation when changes from any of the above requirements might be warranted.

The disclosure shall include a description of the action which the recipient has taken or proposes to take to avoid or mitigate such conflict.
- 2. NHTSA will review the disclosure and may require additional relevant information from the recipient. If a conflict of interest is found to exist, NHTSA may (a) terminate the award, or (b) determine that it is otherwise in the best interest of NHTSA to continue the award and include appropriate provisions to mitigate or avoid such conflict.
- 3. Conflicts of interest that require disclosure include all past, present, or currently planned organizational, financial, contractual, or other interest(s) with an organization regulated by NHTSA or with an organization whose interests may be substantially affected by NHTSA activities, and which are related to this award. The interest(s) that require disclosure include those of any recipient, affiliate, proposed consultant, proposed subcontractor, and key personnel of any of the above. Past interest shall be limited to within one year of the date of award. Key personnel shall include any person owning more than a 20 percent interest in a recipient, and the officers, employees or agents of a recipient who are responsible for making a decision or taking an action under an award where the decision or action can have an economic or other impact on the interests of a regulated or affected organization.

## PROHIBITION ON USING GRANT FUNDS TO CHECK FOR HELMET USAGE (applies to subrecipients as well as States)
