

**AMENDMENT NO. 1 TO THE PROFESSIONAL
SERVICES AGREEMENT BETWEEN THE
CITY OF MANTECA AND FRUIT GROWERS LABORATORY, INC.,
FOR AS-NEEDED ANALYTICAL LABORATORY TESTING SERVICES**

This Amendment No. 1 (“Amendment”) to Agreement #C2022-98 (“Agreement”) between the City of Manteca and Fruit Growers Laboratory, Inc., is made and entered into this ____ day of June 2025, by and between Fruit Growers Laboratory, Inc., a California corporation (“Consultant”) and the City of Manteca, a municipal corporation (“City”).

RECITALS

- A. On July 13, 2022, the City of Manteca approved an Agreement (C2022-98) with Consultant to provide professional services for As-Needed Analytical Laboratory Testing Services; and
- B. Consultant has been engaged in the Services described herein and the term on their current contract ends July 13, 2025. The Consultant has proven that they are capable of providing these services in a time efficient and cost-effective manner; and
- C. City now desires to amend the Agreement to extend the contract term and increase the not-to-exceed amount for Services under the Agreement; and
- D. Consultant represents that it has the necessary professional skills and experience to satisfactorily provide consulting services in a timely manner; and
- E. City desires to engage Consultant for the purposes of completing the scope of services identified;

NOW, THEREFORE, the parties hereby agree as follows:

- 1. Article 3, Time of Performance, of the Agreement is hereby amended as follows:

Delete:

“The services of Consultant are to commence upon execution of this Agreement and shall continue as needed by the City for a period of three (3) years.”

Replace with:

“The services of Consultant are to continue upon execution of this Amendment No. 1 and shall extend to June 30, 2027.”

ATTACHMENT 2

2. Article 4, Compensation, of the Agreement is hereby amended as follows:

Delete:

“Without additional authorization from the City, compensation to be paid to Consultant shall not exceed SEVENTY-FIVE THOUSAND DOLLARS (\$75,000).”

Replace with:

“Without additional authorization from the City, compensation to be paid to Consultant shall not exceed ONE HUNDRED TWENTY-FIVE THOUSAND (\$125,000).”

3. Except as otherwise provided in this Amendment, the Agreement shall continue in full force and effect.
