### RESOLUTION R2024-XX

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING A GRANT FROM THE CALIFORNIA OFFICE OF TRAFFIC SAFETY (CA OTS) SELECTIVE TRAFFIC ENFORCEMENT PROGRAM (S.T.E.P.) APPROVING AN AGREEMENT WITH CA OTS IN THE AMOUNT OF \$125,000 FOR FEDERAL FISCAL YEAR 2025; APPROPRIATE \$125,000 TO POLICE GRANTS (FUND 150) REVENUE AND EXPENDITURE ACCOUNTS; AND AUTHORIZE THE POLICE CHIEF TO SIGN SAID AGREEMENT

WHEREAS, the City of Manteca desires to undertake the Selective Traffic Enforcement Program (S.T.E.P.) Grant administered by the California Office of Traffic Safety hereafter referred to as "CA OTS" in the amount of \$125,000.00 for the project term of October 1, 2024 through September 30, 2025 (Federal Fiscal Year 2025); and

WHEREAS, the Manteca Police Department will use the grant funds to increase criminal enforcement of Driving Under the Influence (DUI) laws and increase traffic enforcement operations for unsafe driving commonly associated with injury and fatal collisions in addition to the receipt of traffic safety equipment and associated training; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council of the City of Manteca approves the appropriation of \$125,000 to Police Grants (Fund 150) revenue and expenditure accounts as necessary to appropriately expend the grant funds prior to September 30, 2025.
3. The City Council agrees that the Police Chief is authorized to execute on behalf of the City Council a contract, including any related documents, extensions, or amendments thereof and any subsequent contract with the State in relation thereto.

4. The City Council agrees that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and CA OTS disclaim responsibility for any such liability.
5. The City Council agrees that this award is not subject to local hiring freezes.
6. This Resolution shall take effect immediately upon its adoption.
