RESOLUTION ACCEPTING ALL IMPROVEMENTS FOR THE 2024 ANNUAL PAVEMENT MAINTENANCE PROJECT CIP 24110 AS COMPLETE, AUTHORIZING THE CITY CLERK TO FILE THE NOTICE OF COMPLETION, AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO COMPLETE AND EXECUTE ALL ASSOCIATED DOCUMENTS, AND TAKE ALL APPROPRIATE ACTIONS NECESSARY TO CARRY OUT THE PURPOSE AND INTENT OF THE RESOLUTION.

WHEREAS, on July 16, 2024, City Council awarded the construction contract C2024-138 for the 2024 Annual Pavement Maintenance Project CIP 24110 (Project) to American Pavement Systems, Inc. (Contractor) for an amount of \$1,515,162.50 and approved a construction contingency of \$303,000 for a total project cost of \$1,818,162.50; and

WHEREAS, the Project was constructed in general conformance with the conformed plans and specifications; and

WHEREAS, the final Project had one change order for an amount of \$93,893.04. The change order include:

- New driveway reconstruction at Fire Station 1
- Tree trimming for clear construction equipment pathway
- Additional pavement repairs on South Powers Avenue and Washington Aveune; and

WHEREAS, the final project construction cost is \$1,521,103.04, the Contractor has submitted the signed final payment certification; and

WHEREAS, there is a 5% retention totaling approximately \$76,055.15 that will be released to the Contractor no sooner than 45 days after filing of the notice of completion; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
