

**1st AMENDMENT OF CONTRACT**  
**BY AND BETWEEN CITY OF MANTECA**  
**AND SDI Presence LLC**

THIS 1st AMENDMENT ("Amendment") to the August 4, 2025 Agreement by and between the City of Manteca and SDI Presence LLC ("Agreement") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_ by and between the CITY OF MANTECA, a municipal corporation of the State of California (hereinafter referred to as "CITY"), and SDI Presence LLC.

RECITALS:

A. WHEREAS, CITY and SDI Presence LLC entered into the Agreement on or around August 4, 2025, for the provision of Technology Modernization and Service Delivery Support; and

B. WHEREAS, the CITY and SDI Presence LLC desire to increase the total compensation for technology modernization and service delivery support to a total of \$155,000 through the contract term under the Agreement.

C. WHEREAS, Section 5. Amendments, Changes or Modifications of the Agreement allows the Parties to mutually agree to amend the Agreement in writing.

NOW, THEREFORE, in consideration of their mutual covenants, the parties hereto agree as follows:

AGREEMENT

1. **INCORPORATION OF RECITALS.** The recitals set forth above are hereby incorporated into this Amendment as if set forth herein in full.

2. **AMENDMENT.**

**Section 3. Compensation**, to the Agreement is hereby amended to read as follows: Compensation to be paid to Consultant shall be in accordance with the Payment Schedule set forth in Exhibit C of Agreement C2025-136, which is incorporated herein by reference. In addition to the Compensation for the Agreement, compensation for Amendment No. 1, shall in no event exceed \$80,000.00 (Eighty Thousand Dollars and Zero Cents) without additional authorization from the City. In no event shall total compensation for work performed pursuant to this Agreement and Amendment No. 1 exceed \$155,000.00 (One Hundred Fifty-Five Thousand Dollars and Zero Cents) without additional authorization from the City.

3. **OTHER TERMS.** Except as expressly amended herein, the Agreement remains in full force and effect. Nothing in this Amendment shall be deemed to waive or modify any of the other provisions of the Agreement. In the event of any conflict between this Amendment and the Agreement, the terms of this Amendment shall prevail.
