RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING ALL IMPROVEMENTS FOR THE MANTECA GOLF COURSE CROM STREET FENCING PROJECT (CIP 24037) AS COMPLETE, AUTHORIZING THE CITY CLERK TO FILE THE NOTICE OF COMPLETION, AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO COMPLETE AND EXECUTE ALL ASSOCIATED DOCUMENTS, AND TAKE ALL APPROPRIATE ACTIONS NECESSARY TO CARRY OUT THE PURPOSE AND INTENT OF THE RESOLUTION.

WHEREAS, on December 3, 2024, City Council awarded the construction contract C2024-198 for the Manteca Golf Course Crom Street Fencing Project (CIP 24037) to Westside Landscape and Concrete, Inc. for (Contractor) for an amount of \$248,190.46 and approved a construction contingency of \$31,809.54 for a total project budget of \$280,000; and

WHEREAS, The Project was constructed in general conformance with the conformed plans and specifications; and

WHEREAS, The final Project had no change orders; and

WHEREAS, The final Project construction cost is \$248,190.46, the Contractor has submitted the signed final payment certification (Attachment 3); and

WHEREAS, The total retention of \$12,409.52 will be released to the Contractor no sooner than 45 days after filing completion; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council hereby accepts all improvements for the Manteca Golf Course Crom Street Fencing Project (CIP 24037) as complete.

3. The City Council hereby authorizes the City Clerk to file the Notice of Completion for the Manteca Golf Course Crom Street Fencing Project (CIP 24037).
4. The City Council hereby authorizes the City Manager or designee to complete and execute all associated documents and take all appropriate actions necessary to carry out the purpose and intent of this resolution.
5. This Resolution shall take effect immediately upon its adoption.
