RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING FEDERAL EMERGENCY SOLUTIONS GRANT (ESG) FUNDS AND AUTHORIZING THE CITY MANAGER TO EXECUTE GRANT AGREEMENTS AND ALL ASSOCIATED DOCUMENTS

WHEREAS, the Emergency Solutions Grants (ESG) Program is a federally funded initiative administered by the U.S. Department of Housing and Urban Development (HUD) to provide assistance to individuals and families experiencing homelessness or at risk of homelessness; and

WHEREAS, ESG funding supports the improvement and operation of emergency shelters, rapid rehousing efforts, and homelessness prevention services; and

WHEREAS, San Joaquin County Neighborhood Preservation Division released a Notice of Funding Availability in December 2024 for Federal ESG funds totaling \$245,000; and

WHEREAS, the City of Manteca has been awarded \$11,771 in Federal ESG funds to support operational costs and services at the Unsheltered Emergency Center located at 555 Industrial Park Drive; and

WHEREAS, the ESG funds will be provided on a reimbursement basis and require temporary use of General Fund resources to cover eligible expenditures; and

WHEREAS, staff recommends appropriating \$11,771 to revenue and expenditure account lines to the HUD Grants Fund (Fund 141) to support project implementation and reimbursement processing.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
- 2. City Council hereby accepts the Federal Emergency Solutions Grant (ESG) funds in the amount of \$11,771 for the Unsheltered Emergency Center located at 555 Industrial Park Drive.
- 3. The City Manager, or designee, is authorized to take all necessary actions to implement this transfer and ensure compliance with all federal grant requirements.

- 4. City Council hereby approves budget appropriations in the amount of \$11,771 in both revenue and expenditure account lines in the HUD Grants Fund (Fund 141).
- 5. This Resolution shall take effect immediately upon its adoption.
