RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING A GRANT FROM THE CALIFORNIA HIGHWAY PATROL, CANNABIS TAX FUND GRANT PROGRAM (CTFGP) IN THE AMOUNT OF \$467,783.47 FOR FISCAL YEAR 2025/2026; APPROPRIATING FUNDS TO THE REVENUE AND EXPENDITURE LINES FOR POLICE GRANTS (FUND 150) AND AUTHORIZING THE CHIEF OF POLICE TO TAKE ALL NECESSARY STEPS TO EFFECTUATE THE AGREEMENT, INCLUDING ANY EXTENSIONS OR AMENDMENTS.

WHEREAS, the City of Manteca desires to undertake the California Highway Patrol, Cannabis Tax Fund Grant administered by the Department of the California Highway Patrol (hereafter referred to as "CHP") in the amount of \$467,783.47 for the project term of July 1, 2025, through June 30, 2026; and

WHEREAS, the Manteca Police Department will use the grant funds to increase criminal enforcement of Driving Under the Influence (DUI) laws, increase traffic enforcement efforts for unsafe driving commonly associated with injury and fatal collisions and acquire police vehicles used by officers to enforce the aforementioned traffic laws.

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
2. Accept the grant from the California Highway Patrol Cannabis Tax Fund Grant Program and appropriate \$467,784 in the Police Grants Fund (Fund 150).
3. The City Council agrees that the Chief of Police of the City of Manteca is authorized to execute on behalf of the City Council a contract, including any extensions or amendments thereof and any subsequent contract with the State in relation thereto pursuant with the Purchasing Policy.
4. The City Council agrees that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State

of California and CHP disclaim responsibility for any such liability.

5. The City Council agrees that this award is not subject to local hiring freezes.

6. This Resolution shall take effect immediately upon its adoption.
