RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING RESPECTIVE SERVICES AGREEMENTS WITH R.E.Y. ENGINEERS, INC. AND DF ENGINEERING, INC. FOR ONCALL CIVIL IMPROVEMENT PLAN CHECK SERVICES

WHEREAS, the City Engineering Department uses on-call consultant civil plan check services when project size, complexity, workload, staffing levels, or current permit activity prevents the delivery of these services from City staff in a timely manner; and

WHEREAS, the City Engineering Department continues to experience very strong development activity requiring these services and as such issued a Request for Proposals (RFP) to invite interested firms to provide proposals for On-Call Civil Improvement Plan Check Services; and

WHEREAS, on April 28, 2025, the City received six proposals and after internal evaluations, staff concluded R.E.Y. Engineers, Inc. and DF Engineering, Inc. to be the most qualified firms to provide the services requested; and

WHEREAS, the City has respectively agreed with R.E.Y. Engineers, Inc. and DF Engineering, Inc. upon a total not-to-exceed amount of \$150,000 in aggregate between the two On-Call Civil Improvement Plan Check Services Agreements over a one-year period for the services; and

WHEREAS, the respective Services Agreements have options for up to two oneyear extensions under the City's sole discretion, resulting in a total potential not-toexceed amount of \$150,000 in aggregate per year for a not-to-exceed sum total of \$450,000 for the services over the three-year period should the City exercise both extensions; and

WHEREAS, the City Council has considered all information related to this matter as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff and any information provided during the public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
- 2. The City Council hereby approves the respective Services Agreements with R.E.Y. Engineers, Inc. and DF Engineering, Inc. for On-Call Civil Improvement
