RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING THE SAN JOAQUIN COUNTY INDEPENDENT CONTRACTOR AGREEMENT FOR BEHAVIORAL HEALTH BRIDGE HOUSING (BHBH) FUNDS IN AN AMOUNT NOT TO EXCEED \$281,000; AUTHORIZING BUDGET APPROPRIATIONS OF \$281,000 EACH TO REVENUE AND EXPENDITURE ACCOUNTS IN THE MISCELLANEOUS GRANTS FUND (FUND 101); AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND ALL RELATED DOCUMENTS

WHEREAS, Behavioral Health Bridge Housing (BHBH) funds are intended to support local jurisdictions in addressing homelessness among individuals with serious behavioral health needs, including those experiencing Serious Mental Illness (SMI) and/or Substance Use Disorders (SUD); and

WHEREAS, Eligible uses of BHBH funds include navigation centers, respite crisis housing, emergency shelters, and other housing-related infrastructure and services that assist individuals experiencing homelessness or those at risk of homelessness; and

WHEREAS, The City of Manteca ("City") has identified a need for supportive and transitional respite housing for San Joaquin County residents with behavioral health conditions who are experiencing homelessness or are at risk of homelessness; and

WHEREAS, The City will collaborate with The WellNest Group and The Way Church, located at 715 E. North Street, Manteca, which is developing The Way Veteran Village, a tiny home community designed to provide supportive, transitional respite housing; and

WHEREAS, The County of San Joaquin ("County") provides behavioral health services to County residents, including individuals who are homeless or at risk of homelessness with serious behavioral health conditions; and

WHEREAS, The California Department of Health Care Services (DHCS) awarded Behavioral Health Bridge Housing (BHBH) program funds to the County for the purpose of reducing homelessness among individuals with SMI and/or SUD; and

WHEREAS, The County has agreed to provide BHBH funding to the City to support the purchase and installation of tiny homes at The Way Veteran Village, which upon installation will provide four (4) beds designated for San Joaquin County residents referred by the County, including individuals who are homeless or at risk of homelessness with serious behavioral health conditions, justice-involved individuals, with prioritization for CARE Court participants; and

WHEREAS, The total amount of funding under the San Joaquin County Independent Contractor Agreement shall not exceed Two Hundred Thousand Eighty-One Thousand Dollars (\$281,000), and the funds are reimbursable.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council hereby accepts the San Joaquin County Independent Contractor Agreement between the City of Manteca and the County of San Joaquin for Behavioral Health Bridge Housing (BHBH) funds in an amount not to exceed \$281,000 for the purchase and installation of tiny homes at The Way Veteran Village, located at 715 E. North Street, Manteca, California.
3. The City Manager is hereby authorized to execute the Independent Contractor Agreement and all related grant agreements, amendments, and associated documents necessary to carry out the purposes of this Resolution.
4. The City Council hereby authorizes budget appropriations of \$281,000 each to revenue and expenditure accounts in the Miscellaneous Grants Fund (Fund 101).
5. This Resolution shall take effect immediately upon its adoption.
