RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA. STATE OF CALIFORNIA, ACCEPTING EMERGENCY FEDERAL AND STATE SOLUTIONS GRANT (ESG) FOR THE UNSHELTERED EMERGENCY CENTER IN THE AMOUNT OF \$21,960 (FEDERAL) AND \$9,640 (STATE); APPROVING BUDGET APPROPRIATIONS OF \$31,600 TO GENERAL FUND INTERGOVERNMENTAL GRANT REVENUE AND GENERAL FUND HOMELESS PROGRAM EXPENDITURE ACCOUNTS; AND AUTHORIZING THE CITY MANAGER GRANT AGREEMENTS AND ALL EXECUTE TO ASSOCIATED DOCUMENTS

WHEREAS, the Emergency Solutions Grants (ESG) program is a federally funded initiative designed to assist individuals and families experiencing homelessness or at risk of becoming homeless, by improving emergency shelters, rapidly rehousing individuals and families, and preventing homelessness through essential services and operational support; and

WHEREAS, the Federal ESG program is administered by the U.S. Department of Housing and Urban Development (HUD) and the State ESG program is provided through the California's Department of Housing and Community Development (HCD) to address homelessness; and

WHEREAS, in December 2023 and 2024, San Joaquin County – Neighborhood Preservation Division released Notices of Funding Availability for Federal ESG and State ESG funds, and the City of Manteca has been awarded the following grants to support the operational costs and services at the Unsheltered Emergency Center located at 555 Industrial Park Drive on a reimbursement basis:

- 2023 Federal ESG: \$8,850
- 2024 Federal ESG: \$13,110
- 2023 State ESG: \$9,640

WHEREAS, the combined Federal ESG awards total \$21,960, and the State ESG award totals \$9,640, for a total award of \$31,600; and

WHEREAS, per the agreements for each grant, the time of performance is extended while the City is in control of the ESG funds; and

WHEREAS, the City shall keep written records in order to account for any changes, amendments, and/or edits to the agreements, including, but not limited duration, scope, and, costs;

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
- 2. City Council accepts the Federal and State Emergency Solutions Grants (ESG) in the amount of \$21,960 (Federal) and \$9,640 (State).
- 3. City Council approves a budget appropriation of \$31,600 to General Fund Intergovernmental Grant revenue account and \$31,600 to General Fund Homeless Program expenditure account.
- 4. Authorizes the City Manager to execute grant agreements and all associated documents.
- 5. This Resolution shall take effect immediately upon adoption.
