



PROPOSED BUDGET OVERVIEW




- Citywide Operating Budget Revenues total \$253M
 - \$73.8M from General Fund
- Citywide Operating Budget Expenses total \$255M
 - \$73.8M from General Fund
- \$2M shortfall - use of General Fund Reserves
- Capital Budget totals \$61M
- Council goals support 5 new FTEs, service enhancements, new projects
- Sales Tax Measure under consideration.

CITYWIDE EXPENSES BY FUND TYPE



- Enterprise - \$77.4M
- General Fund - \$73.8M
- Capital Improvements - \$51.7M
- Special Revenue - \$35.4M
- Internal Service - \$17.3M
- Other Funds - \$62,000




GENERAL FUND REVENUES



Total Revenues - \$73.8M

- Property Tax - modest increase
- TOT - tax-sharing agreement
- Sales Tax - trending flat
- Red Light Camera Program (offset by expenses)

TOT Schedule - GWL	FY 2021-22	FY 2022-23	FY 2023-24 (YTD)
Due to Developer (GWL)	3,368,178	3,598,537	2,000,000
Due to City (Manteca)	1,839,619	2,018,787	766,123
Total TOT Collected	5,207,798	5,617,325	2,766,123

- **City - 25% off the top**
- **GWL - next \$2M**
- **City - 10% of land purchase of 10 year period (67,500 annually)**
- **City - 5% deferred fees paid over 20 years (450,975 annually)**
- **GWL - 75% remainder of TOT first 10 years; 50% remaining 15 years**
- **City - 25% remainder of TOT first 10 years; 50% remaining 15 years**




GENERAL FUND EXPENSES



Total Expenses - \$73.8M




5-YEAR TREND





SEWER FUND TRENDS




WATER FUND TRENDS







FISCAL CHALLENGES

UNFUNDED POSITIONS

- 44 new FTEs requested; **39 unfunded**
- 15 position reclassifications requested; **11 unfunded**
- 72 equity adjustments requested; **70 unfunded**

- Facilities: City Hall, Public Safety Buildings & Equipment, Pool
- Wastewater Plant Expansion

- Positions


OVERCOMING CHALLENGES

- **Tax Measure Exploration**




SALES TAX BREAKDOWN

- Manteca has an 8.25% sales tax
- City receives only 1.5¢ per \$1.00
- Generates \$16-24M annually



POTENTIAL SALES TAX BREAKDOWN

- Manteca would have a 9.25% sales tax
- City would receive 2.5¢ per \$1.00
- Would generate an **ADDITIONAL \$16-24M annually**
