RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING THE PARKS AND RECREATION MASTER PLAN UPDATE

WHEREAS, the City of Manteca last adopted a Parks and Recreation Master Plan November 7, 2016; and

WHEREAS, since adoption of the 2016 Parks and Recreation Master Plan, the City has experienced continued residential growth, evolving recreation trends, increased community expectations, and rising construction and operational costs; and

WHEREAS, the City initiated an update to the Parks and Recreation Master Plan to ensure it remains a relevant, strategic, and implementable guide for the long-term planning, development, and management of parks, trails, recreation facilities, open space, and programs; and

WHEREAS, the Parks and Recreation Master Plan Update builds upon the framework of the previously adopted plan and incorporates updated demographic data, community input, facility assessments, participation trends, and industry best practices; and

WHEREAS, community engagement and stakeholder input were integral to the Parks and Recreation Master Plan Update process and included public outreach, targeted surveys, coordination with City staff, review of participation data, and technical analysis; and

WHEREAS, the Parks and Recreation Master Plan Update provides guidance for maintaining existing park assets while planning for future growth and aligns park and recreation planning with the City's broader land use, development, and capital planning efforts; and

WHEREAS, the Parks and Recreation Master Plan Update does not commit the City to a specific funding schedule or capital investment timeline, and implementation will occur incrementally over time subject to future City Council review through the annual Capital Improvement Program and budget processes; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:
