RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING THE IMPROVEMENT AGREEMENT AND LARGE LOT FINAL MAP FOR EMBLEM MANTECA, FORMERLY KNOWN AS "144-490 QUINTAL ROAD PROJECT", TRACT 4276; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SIGN AND TAKE ALL NECESSARY STEPS TO EFFECTUATE THE AGREEMENT AND AUTHORIZING THE MAYOR TO SIGN THE FINAL MAP

WHEREAS, on November 19, 2024, the City Council approved the Tentative Subdivision Map for Emblem Manteca, formerly known as "144-490 Quintal Road Project"; and

WHEREAS, in accordance with the City of Manteca Municipal Code, Title 16, QMC Manteca Holdings, LLC (Developer), developer of the subdivision has presented to the City Council of the City of Manteca the Improvement Agreement and Large Lot Final Map for the Emblem Manteca subdivision; and

WHEREAS, in accordance with the Manteca Municipal Code, Title 16, Developer will post the required surety bonds in the amounts specified in the Reference Data section of the Improvement Agreement; and

WHEREAS, with the approval of the Large Lot Final Map, the City Council will abandon the portion of E. Quintal Road right-of-way along the northern boundary of the map in accordance with the Conditions of Approval; and

WHEREAS, the Large Lot Final Map has been reviewed and is in conformance with the approved Tentative Map and is technically correct; and

WHEREAS, the Large Lot Final Map complies with the California Subdivision Map Act, the City of Manteca General Plan, and the City of Manteca Municipal Code; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.

2. The City Council hereby approves the Improvement Agreement and the Large Lot Final Map for Emblem Manteca, Tract 4276.
3. The City Council hereby approves the abandonment of E. Quintal Road.
4. The City Council does hereby authorize the City Manager or designee to sign and take all necessary steps to effectuate the agreement on behalf of the City of Manteca and authorizes the City Clerk to attest thereto and impress the official seal upon the same.
5. The City Council does hereby authorize the Mayor of the City of Manteca to sign the Large Lot Final Map, on behalf of the City of Manteca, and authorizes the City Clerk to attest thereto and impress the official seal upon the same.
6. This Resolution shall take effect immediately upon adoption.
