RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING PUBLIC IMPROVEMENTS FOR THE CROSSING - MANTECA; APPROVING EXONERATION OF THE PERFORMANCE BOND; APPROVING EXONERATION OF THE LABOR AND MATERIALS BOND SIX (6) MONTHS AFTER THE DATE OF ACCEPTANCE; AND APPROVING EXONERATION OF THE WARRANTY BONDS TWELVE (12) MONTHS AFTER THE DATE OF ACCEPTANCE

WHEREAS, Diamond Galaxy Partners LLC (Owner) is constructing a retail shopping center at 1527 S. Airport Way that includes one major grocery store, retail shops, quick service restaurants, a car wash, a fuel stop, and a cellular tower; and

WHEREAS, Owner was conditioned to construct various offsite transportation improvements including street resurfacing, traffic signal improvements for S. Airport Way at W. Atherton Drive and Langum Way at W. Atherton Drive; medians; signing & striping; drainage facilities; street lights; and utilities; and

WHEREAS Owner entered an Improvement Agreement to construct the offsite improvements which was approved by the City Council of the City of Manteca on April 2, 2024; and

WHEREAS, Owner has requested the City Council of the City of Manteca, a Municipal Corporation (City), accept the public improvements for The Crossing - Manteca; and

WHEREAS, the General Plan Public Facilities and Services Element Goal PF-5 states that, "The City's public services and facilities will support economic development and residential growth in the City"; and

WHEREAS, the public improvements have been inspected, tested and completed to the satisfaction of the Engineering Department of the City; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.

2. The City Council hereby finds that the public improvements for The Crossing - Manteca are complete and are hereby accepted.
3. The City Council hereby assumes all future maintenance of the completed public improvements.
4. The Faithful Performance Bond in the amount of \$2,975,990 on deposit with the City, is hereby exonerated upon receipt by City of Warranty Bond in the amount of \$297,599 as provided in the Improvement Agreement between City and Owner.
5. The City Engineer is hereby authorized to exonerate the Labor and Materials Bond in the amount of \$1,487,995 six months after acceptance of said improvements if no claims have been filed.
6. The City Engineer is hereby authorized to exonerate the Warranty Bond twelve (12) months after the date of acceptance, upon re-inspection of the improvements which are found to be in good condition or after any defects have been repaired, as determined by the City Engineer.
7. The City Clerk is hereby instructed to record this Resolution with the San Joaquin County Recorder's Office.
8. This Resolution shall take effect immediately upon adoption.
