RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING THE IMPROVEMENT AGREEMENT AND FINAL MAP FOR VILLA TICINO WEST UNIT NO. 8, TRACT 4177; AUTHORIZING THE CITY MANAGER TO SIGN AND TAKE ALL NECESSARY STEPS TO EFFECTUATE THE AGREEMENT AND AUTHORIZING THE MAYOR TO SIGN THE FINAL MAP

WHEREAS, the Villa Ticino West Subdivision Tentative Map was approved by the City Council of the City of Manteca on July 21, 2015; and

WHEREAS, in accordance with the City of Manteca Municipal Code, Title 16, AG EHC II (MTH) CA 2, L.P., a Delaware limited partnership (Developer), developer of Villa Ticino West Unit No. 8, has presented to the City Council of the City of Manteca the Improvement Agreement and Final Map for the Villa Ticino West Unit No. 8 subdivision, Tract 4177; and

WHEREAS, in accordance with Title 16 of the Manteca Municipal Code, the Developer has posted the required surety bonds in the amounts specified in the Reference Data section of the Improvement Agreement; and

WHEREAS, the Final Map has been reviewed, is in conformance with the approved Tentative Map, and is technically correct; and

WHEREAS, the Final Map complies with the California Subdivision Map Act, the City of Manteca General Plan and the City of Manteca Municipal Code; and

WHEREAS, the City Council has considered all information related to this matter as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
- 2. The City Council does hereby approve the Improvement Agreement and the Final Map for the Villa Ticino West Unit No. 8, Tract 4177.

- 3. The City Council does hereby authorize the City Manager to sign and take all necessary steps to effectuate the agreement on behalf of the City of Manteca and authorizes the City Clerk to attest thereto and impress the official seal upon the same.
- 4. The City Council does hereby authorize the Mayor of the City of Manteca to sign the Final Map, on behalf of the City of Manteca, and authorizes the City Clerk to attest thereto and impress the official seal upon the same.
- 5. This Resolution shall take effect immediately upon its adoption.
