## RESOLUTION R2024-XX

### RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING GRADING AND CONSTRUCTION OF IMPROVEMENTS PRIOR TO FILING OF THE FINAL MAP FOR GRIFFIN PARK UNIT NO. 6 SUBDIVISION

WHEREAS, Griffin Park Development Company LLC, developer of the 1,301 lot Griffin Park Unit No. 6 subdivision, has submitted a written request to begin grading and construction of improvements prior to filing of the Filing Map in accordance with the Manteca Municipal Code (MMC) Title 16, Section 16.13.060; and

WHEREAS, all conditions of MMC Title 16, Section 16.13.060 (B)(1) through (B)(5) will be met prior to the start of work; and

WHEREAS, the City Council has considered all information related to this matter as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council hereby makes the following determinations in accordance with MMC Title 16, Section 16.13.060 (B)(5):
  - a. The approved work is not likely to cause substantial environmental damage;
  - b. The approved work is not likely to substantially and avoidably injure fish or wildlife or their habitat;
  - c. The approved work is not likely to cause serious public health problems; and
  - d. The approved work is not likely to injure any nearby property, whether the subdivision is completed or abandoned.
3. Approval of this request does not relieve the developer of the need to obtain the necessary permits, comply with the requirements of Title 16, Section 16.13.060 of the Manteca Municipal Code, or any other relevant federal, state, or local statute, code, or regulation.
