RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING PLANS AND SPECIFICATIONS FOR THE COMPRESSED NATURAL GAS (CNG) SAFETY SYSTEMS FOR FLEET SHOP (CIP 24121), APPROVING THE CALIFORNIA ENVIRONMENTAL QUALITY ACT NOTICE OF EXEMPTION DETERMINATION, AUTHORIZING A CALL FOR BIDS, AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO TAKE ALL APPROPRIATE ACTIONS NECESSARY TO CARRY OUT THE PURPOSE AND INTENT OF THE RESOLUTION (EXEMPT FROM CEQA PURSUANT TO 14 CAL. CODE REG. § 15301(D))

WHEREAS, Plans, Specifications and Estimates for the Compressed Natural Gas (CNG) Safety Systems for Fleet Shop (CIP 24121) are complete and available for review in the Solid Waste Division Office; and

WHEREAS, The CNG Safety Systems for Fleet Shop Project a vital to enhance operational safety and ensure full compliance with California safety codes. While current systems meet some regulatory standards, gaps remain that require targeted upgrades and possible expansions. Upgrading these systems is essential to create a safe working environment and achieve full regulatory compliance; and

WHEREAS, staff has reviewed and determined that the project is Categorically Exempt under the California Environmental Quality Act (CEQA) based on Article 19 Section 15301(d), Class 1 “Existing Facilities”; and

WHEREAS, a Notice of Exemption will be filed with the San Joaquin County Clerk/Recorder and the State Clearinghouse for the Project pursuant to 14 Cal. Code Regs. § 15094; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council’s adoption of this Resolution.

2. The City Council hereby approves the Plans, Specifications and Estimate for the Compressed Natural Gas (CNG) Safety Systems for Fleet Shop (CIP 24121).
3. The City Council hereby approves the California Environmental Quality Act Notice of Exemption determination for the Project.
