RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING A BUDGET APPROPRIATION OF \$201,000 FROM THE GENERAL FUND FIRE MUTUAL AID REIMBURSEMENT REVENUE ACCOUNT AND AMEND THE FY25 CAPITAL IMPROVEMENT PROGRAM (CIP) FOR RADIO COMMUNICATIONS INFRASTRUCTURE UPGRADE (CIP NO. 24009)

WHEREAS, the City of Manteca maintains a Radio Communications Infrastructure critical to the delivery of public safety services and emergency response coordination; and

WHEREAS, the existing radio communications system has reached the end of its useful life and requires upgrades to ensure operational reliability, regional interoperability, and compliance with modern technology standards; and

WHEREAS, the Radio Communications Infrastructure Upgrade Project (CIP No. 24009) was established in the City's Capital Improvement Program to address these needs; and

WHEREAS, updated project cost estimates have identified a need for an additional \$201,000 to complete the planned infrastructure improvements; and

WHEREAS, the City's General Fund Fire Mutual Aid Reimbursement Revenue Account has received increased revenue as a result of the Fire Department's continued participation in Long Term Mutual Aid (LTMA) operations, and sufficient funds are available to support the proposed budget appropriation; and

WHEREAS, the City Council desires to appropriate \$201,000 from the General Fund Fire Mutual Aid Reimbursement Revenue Account to the Radio Communications Infrastructure Upgrade Project (CIP No. 24009) and amend the Capital Improvement Program accordingly;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and they establish the factual basis for the City Council's adoption of this Resolution.
2. Approves a budget appropriation in the amount of \$201,000 from the General Fund Fire Mutual Aid Reimbursement Revenue Account to the General Fund

Capital Outlay Equipment Replacement expenditure account for Radio Communications Infrastructure Upgrade Project (CIP No. 24009).

3. The City's Capital Improvement Program is hereby amended to reflect the increased project funding for CIP No. 24009 as specified above.
4. The City Council finds that the City Manager shall have the authority to execute any and all documents and/or amendments in order to effectuate this Resolution.
5. This Resolution shall take effect immediately upon adoption.
