Assistant Planner, Allison Diaz presented the item as described in the staff report prepared for the Project. The Project's representative Brian Cournoyer addressed the Planning Commission requesting approval of the Project. Commissioners Coleman, Mendoza, Chair Fiore asked questions from Mr. Brian Cournoyer stated he agreed with the conditions of approval for the project and that both projects will be completed around the same time with the way things are going.

Public Comment was provided by Mr. Sean Randall regarding concerns with the site ingress, the Dennis Pocket Area, and potential creation of new traffic flow patterns that are not ideal for Daniels Street and that a more egress pockets are needed to create better merging abilities and for people to be able to back out safely. No additional comments were received via Zoom, comment cards, of in-person.

## **CLOSED PUBLIC HEARING: 6:42 pm**

Mr. Brian Cournoyer was given the opportunity to provide a rebuttal to the public comment provided. Mr. Brian Cournoyer raised concerns on the change of submittal for the project to include more ingress/egress. Mr. Cournoyer suggests that if Planning Commission wishes to abide by this, then the project will have to be back tracked with Engineering in order to resubmit and will affect both sites. Commissioners Jimenez, Coleman, Paslak, Chair Fiore) had additional comments and questions of/for Mr. Brian Cournoyer regarding additional egress concerns and options for the site, conflict in phasing of the projects as well as traffic flow control after the project is completed. Chair Fiore raised additional concerns about the addition of bicycle lanes on Daniels Street and encourages the City to not add them due to the possibility of too much traffic congestion in the future.

Senior Planner, Dave Ruby presented the item as described in the staff report prepared for the Project. Assistant City Attorney Daniella Green provided clarification for the Planning Commission.

## **OPEN PUBLIC HEARING: 7:09 pm**

The Project's applicant Fritz Huber on behalf of Groupe Huber addressed the Planning Commission requesting approval of the Project. Commissioners Coleman asked questions from Mr. Fritz Huber. Mr. Fritz Hubers stated he was in agreement with the conditions of approval for the project.

Mr. Sudarshar Satti provided public comment with regards to concerns with zoning of project as well as other potential uprising of nicotine and cannabis shops within 600 feet of school zones.

Mr. Sean Randall provided public comment with regards to the Promenade Shops that tandem shops such as tobacco, cannabis and night clubs not belong in that area as it is family-oriented space.

## **CLOSED PUBLIC HEARING: 7:17 pm**

Mr. Fritz Huber was given the opportunity to provide a rebuttal to the public comment provided. Huber commented that the intention of the Plan Development is to stay consistent with the underlying zoning for general commercial use and they have no intention of adding more tandem shops at Promenade. Commissioners Coleman) had additional comments and questions of/for Mr. Fritz Huber.

Assistant City Attorney, Daniella Green provided clarification for the Planning Commission. Deputy Director of Development Services, Jesus Orozco provided recommended language for a possible action.
