

RESOLUTION R2026-XX

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING THE DONATION OF ONE (1) REFURBISHED 8'X40' INSULATED DOG KENNEL CONTAINER FROM VAULT, CO. FOR USE AT THE CITY'S UNSHELTERED EMERGENCY CENTER AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE ALL ASSOCIATED DOCUMENTS NECESSARY TO ACCEPT THE DONATION

WHEREAS, Vault, Co. has offered to donate one (1) refurbished 8'x40' insulated dog kennel container ("Dog Kennel Container") to the City of Manteca for use at the City's Unsheltered Emergency Center ("Center"); and

WHEREAS, the Center provides temporary shelter and supportive services to individuals experiencing homelessness in the City of Manteca; and

WHEREAS, the Dog Kennel Container will provide a secure, insulated, and climate-controlled shelter for dogs belonging to residents of the Center, helping protect animals during periods of extreme heat and cold while reducing barriers for individuals seeking shelter and services with their pets; and

WHEREAS, His Way Refuge Center, the City's contracted operator of the Center, will oversee the daily operation of the Dog Kennel Container, while residents will remain responsible for the care, feeding, supervision, and cleanup of their pets; and

WHEREAS, the City will coordinate with the Manteca Animal Services Division to assist residents with pet licensing, vaccinations, and access to low-cost spay and neuter services to support responsible pet ownership and future housing placement opportunities; and

WHEREAS, acceptance of the Dog Kennel Container will further the City's efforts to provide low-barrier shelter services while promoting the health, safety, and welfare of residents and their pets; and

WHEREAS, there is no cost to the City for the donated Dog Kennel Container.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.

2. The City Council hereby accepts the donation of one (1) refurbished 8'x40' insulated Dog Kennel Container from Vault, Co. for use at the City's Unsheltered Emergency Center.
3. The City Manager, or designee, is hereby authorized and directed to execute all agreements, donation documents, and any other documents necessary to accept the donation and carry out the intent of this Resolution.
4. This Resolution shall take effect immediately upon its adoption.
