

RESOLUTION R20XX-XX

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING AN AGREEMENT WITH SDI PRESENCE LLC. IN THE AMOUNT OF \$203,550 FOR PROFESSIONAL SERVICES TO SUPPORT THE MAINTENANCE AND UPDATING OF THE CITY'S GIS UTILITY LAYERS, APPROVE A BUDGET APPROPRIATION of \$203,550 FOR AN EQUAL DISTRIBUTION (25% EACH) FROM VARIOUS FUNDS AND AUTHORIZE THE CITY MANAGER OR THEIR DESIGNEE TO EXECUTE ALL NECESSARY DOCUMENTS.

WHEREAS, the City acknowledges the need to support the maintenance and updating of the City's GIS (Geographic Information Systems) utility layers. Utility infrastructure, such as water, sewer, and storm drain systems, is foundational to the City's ability to deliver essential services to the community. These systems support everything from safe drinking water and wastewater management to system reliability during construction and repair activities. To effectively manage, maintain, and plan for this critical infrastructure, City departments rely on accurate, up-to-date utility information; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council hereby approves an agreement with SDI Presence LLC., in the amount of \$203,550 for professional services to support the maintenance and updating of the City's GIS utility layers.
3. Approve the following appropriations totaling \$203,552:
 - a. \$50,888 in the Development Services Fund (Fund 340)
 - b. \$50,888 in the Sewer O&M Fund (Fund 640)
 - c. \$50,888 in the Water O&M Fund (Fund 680)
 - d. \$50,888 in the Engineering Fund (Fund 810)

4. The City Council hereby approves and authorizes the City Manager to sign an agreement with SDI Presence, LLC. through June 30, 2026, for the maintenance and updating of the GIS utility layers and execute all associated documents and take all appropriate actions necessary to carry out the purpose and intent of the resolution.
5. This Resolution shall take effect immediately upon adoption.
