RECOMMENDING THE CITY COUNCIL MAKE THE NECESSARY FINDINGS AND  
ADOPT A TIERED INITIAL STUDY AND NEGATIVE DECLARATION (SCH  
#2025071350) PREPARED FOR THE PROJECT AND ADOPT THE 2025 CLIMATE  
ACTION PLAN UPDATE**

WHEREAS, on October 15, 2013, the Manteca City Council adopted the Air Quality Element Update and Climate Action Plan in response to the passing of Assembly Bill 32; and

WHEREAS, Assembly Bill 32 and Senate Bill 32 establish Statewide GHG reduction goals and Executive Order B-55-18 commits the State to carbon neutrality by 2045; and

WHEREAS, the Climate Action Plan is a citywide policy document that will be updated every five years moving forward; and

WHEREAS, City of Manteca General Plan Resource Conservation Implementation Measure RC-4a requires that the Climate Action Plan shall be updated by 2025 and subsequently reviewed every 5 years and updated as necessary to be consistent with State-adopted GHG reduction targets, including revisions to GHG reduction measures to ensure effective implementation; and

WHEREAS, an Initial Study/Negative Declaration (SCH # 2025071350) included as Exhibit 'A', was prepared pursuant to Section 15070 of the California Environmental Quality Act (CEQA) Guidelines; and

WHEREAS, the Initial Study/Negative Declaration (SCH # 2025071350) was made available for public review beginning on July 31, 2025 for no less than 30 days pursuant to Section 15073 of the California Environmental Quality Act (CEQA) Guidelines; and

WHEREAS, the Initial Study/Negative Declaration (SCH # 2025071350) is in the custodial of the Development Services Department located at 1215 W Center St Ste. 201, in Manteca CA pursuant to Section 15074(a) California Environmental Quality Act (CEQA) Guidelines; and

WHEREAS, City staff has worked with the Climate Action Plan committee in the preparation of 2025 Climate Action Plan, in concert with conducting community outreach as part of the update process; and

WHEREAS, a final draft of the 2025 Climate Action Plan, included as Exhibit 'B', has been prepared for final review and adoption by the City Council; and

WHEREAS, as part of the City's development review process, City staff screens projects for compliance with the Climate Action Plan using a Sustainability Checklist which can be updated by the Development Service Director as deemed necessary; and

WHEREAS, all legal prerequisites to adopt the foregoing resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED, that the Planning Commission of the City of Manteca, upon evidence in the staff report, the Project file, and public testimony now desires to recommend the City Council of the City of Manteca approve the 2025 Climate Action Plan Update based on the following findings:

- 1) Recitals. All facts set forth in the recitals above are true and correct and incorporated herein by reference.
- 2) CEQA. An Initial Study/Negative Declaration (SCH # 2025071350) included as Exhibit 'A', was prepared pursuant to Section 15070 of the California Environmental Quality Act (CEQA) Guidelines.
- 3) Climate Action Plan Update. The 2025 Climate Action Plan, included as Exhibit 'B', has been prepared for final review and adoption by the City Council.
- 4) Effective Date. Approval shall take effect immediately upon adoption of this Resolution.
