RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING A GRANT FROM THE CALIFORNIA OFFICE OF EMERGENCY SERVICES (CALOES) THROUGH THE STATE AND LOCAL CYBERSECURITY GRANT PROGRAM (SLCGP), IN THE AMOUNT OF \$250,000; APPROVING AN APPROPRIATING OF \$250,000 TO MISCELLANEOUS GRANTS (FUND 101) REVENUE AND EXPENDITURE ACCOUNTS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE REQUIRED DOCUMENTS

WHEREAS, the City of Manteca has been awarded \$250,000 through the State and Local Cybersecurity Grant Program (SLCGP), administered by the California Office of Emergency Services (CalOES), to strengthen local cybersecurity resilience; and

WHEREAS, the City will use the grant funds to support the development of a Citywide Cybersecurity Plan, implement continuous system monitoring, conduct vulnerability testing, and conduct a long-term staffing strategy; and

WHEREAS, the grant operates on a reimbursement basis, requiring the City to incur eligible costs prior to receiving funds; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council of the City of Manteca accepts the \$250,000 grant from the California Office of Emergency Services through the State and Local Cybersecurity Grant Program.
3. The City Council approves an appropriation of \$250,000 to Miscellaneous Grant Fund revenue.
4. The City Council approves and appropriation of \$250,000 to Miscellaneous Grant Fund expenditures.

5. The City Council authorizes the City Manager to execute the Governing Body Authorization Form and any other documents necessary to administer the grant, including extensions, amendments, or future related contracts with the State.

6. This Resolution shall take effect immediately upon its adoption.
