RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, AUTHORIZING THE APPROVAL OF A BUDGET APPROPRIATION OF \$299,954 IN THE MEASURE Q FUND (FUND 105) FOR REIMBURSEMENT TO MANTECA UNIFIED SCHOOL DISTRICT FOR THE JOSHUA COWELL MODERNIZATION OFF-SITE IMPROVEMENTS ON CHARDONNAY WAY AND MICHELETOS WAY (BOUNDED BY NEHEMIAH DRIVE AND VASCONCELLOS AVENUE); AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO COMPLETE AND EXECUTE ASSOCIATED DOCUMENTS AND TAKE ALL APPROPRIATE ACTIONS NECESSARY TO CARRY OUT THE PURPOSE AND INTENET OF THIS RESOLUTION

WHEREAS, in May 2025, the City entered into an agreement with Manteca Unified School District (MUSD) for MUSD to provide school bus access to Joshua Cowell School from Chardonnay Way and the City agreed to reimburse MUSD for the off-site improvements which included installation of ADA curb ramps and placement of a new asphalt overlay on Chardonnay Way and Micheletos Way upon completion of the work; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council hereby authorizes a budget appropriation of \$299,954 in the Measure Q Fund (Fund 105) for the total reimbursement to MUSD.
3. The City Council hereby authorizes the City Manager or designee to complete and execute associated documents and take all appropriate actions necessary to carry out the purpose and intent of this resolution.
4. This Resolution shall take effect immediately upon adoption.
