ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
MANTECA, STATE OF CALIFORNIA, AMENDING  
CHAPTER 2.28 RECREATION AND PARKS COMMISSION  
SECTION 2.28.010 CREATED

WHEREAS, at the City Council Special meeting on June 8, 2021, the City Council requested staff to work with Manteca Unified School District (MUSD) on adding an additional alternate position to Recreation and Parks Commission, to be appointed by MUSD; and

WHEREAS, at the City Council meeting on March 15, 2022, the City Council adopted Ordinance O2022-08, amending Chapter 2.28 Recreation and Parks Commission section 2.28.020, authorizing an additional alternate member position to be appointed by MUSD; and

WHEREAS, Ordinance O2022-08 increased the Recreation and Parks Commission membership from six members to seven members; and

WHEREAS, Chapter 2.28 Recreation and Parks Commission Section 2.28.010 incorrectly states that the Recreation and Parks Commission consists of six members; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meeting of the City Council identified herein, including any supporting reports by City staff, and any information provided during public meetings.

THE CITY COUNCIL OF THE CITY OF MANTECA DOES ORDAIN AS FOLLOWS:

**SECTION 1: Amendment.** Manteca Municipal Code section 2.28.010 Created is hereby amended to read as follows:

**2.28.010 Created.**

There is created a recreation and parks commission consisting of five members and two alternate members. The alternate members shall attend all meetings of the commission and are authorized to serve and vote in place of any regular member of the commission who is absent. (Ord. 1437 § 3, 2009; Ord. 1083 § 1, 1998; prior code § 2-20)

**SECTION 2: Severability.** If any section, sub-section, subdivision, paragraph, clause, or phrase in this Ordinance, or any part thereof, is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections or portions of this Ordinance or any part thereof. declares that it would have passed each section, sub-section, subdivision, paragraph, sentence, clause or phrase of this Ordinance, irrespective of the fact that any one or more sections, sub-sections, subdivisions, paragraphs, sentences, clauses or phrases may be declared invalid or unconstitutional.

**SECTION 3: Effective Date.** This Ordinance shall become effective thirty (30) days following adoption.
