RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, AUTHORIZING SUBMISSION OF APPLICATIONS FOR ALTERNATIVE FUEL VEHICLE GRANTS FROM THE SAN JOAQUIN VALLEY AIR POLLUTION CONTROL DISTRICT, AND AUTHORIZING CITY MANAGER OR THEIR DESIGNEE TO EXECUTE SAID APPLICATIONS AND ALL ASSOCIATED DOCUMENTS

WHEREAS, the San Joaquin Valley Air Pollution Control District (SJVAPCD) has authorized the establishment of the Public Benefit Grant Program, providing funds for the purchase of alternative fuel vehicles; and

WHEREAS, said adopted procedures established by the SJVAPCD requires applicants to certify by resolution the approval to submit applications to the SJVAPCD; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
- 2. Approves the filing of applications for the Public Benefit Grant Program from the San Joaquin Valley Air Pollution Control District and acceptance of grant funds and participation therein, consistent with constitutional and local law requirements and this resolution.
- 3. Appoints and authorizes the City Manager or their designee as the agent for the City of Manteca to execute and submit all application documents, materials, certifications, agreements, amendments, requests for reimbursement, perform any necessary budget amendments, and so on which may be necessary in the pursuit hereof, subject to prior approval as to form by the City Attorney's Office.
