

RESOLUTION R2026-32

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING AN AMENDMENT BETWEEN THE BOARD OF ADMINISTRATION CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM AND THE CITY COUNCIL CITY OF MANTECA TO PROVIDE PROVISIONS OF RETIREMENT LAW (GOVERNMENT CODE) SECTION 20516, EMPLOYEE COST SHARING

WHEREAS, the Public Employees' Retirement Law permits the participation of public agencies and their employees in the Public Employees' Retirement System by the execution of a contract, and sets forth the procedure by which said public agencies may elect to subject themselves and their employees to amendments to said law; and

WHEREAS, one of the steps in the procedures to amend this contract is the adoption by the governing body of the public agency of a resolution giving notice of its intention to approve an amendment to said contract, which resolution shall contain a summary of the change proposed in said contract; and

WHEREAS, the following is a statement of the proposed change:

To provide Section 20516 (Employees Sharing Additional Cost) of 9% for first-tier classic local fire members in the Manteca Firefighters IAFF Local, 1874; 5.75% for local miscellaneous members in the Mid-Manager Association; 11% for local miscellaneous members in the Manteca Police Employees' Association; 8% for local miscellaneous members, local police members, and first-tier classic local fire members and new local fire members in the Unrepresented Executive Management group; and 5.75% for local miscellaneous members, first-tier classic local fire members, new local fire members, and local police members in the Unrepresented Management & Exempt-Level Confidential Employees Unit.

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.

2. The City Council hereby gives notice of intention to approve an amendment to the contract between said public agency and the Board of Administration of the Public Employees' Retirement System, a copy of said amendment being attached hereto, as Exhibit "A" and by this reference made a part hereof.
3. The City Council hereby gives notice of intention to is compliance with Government Code section 7507 and section 20516, respectively, and consistent with Exhibits "B", "C", "D" and "E".
4. This Resolution shall take effect immediately upon adoption.
