RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, AND THE UNREPRESENTED EMPLOYEE GROUPS RELATING TO GC 20516(B) COST SHARE

WHEREAS, the Unrepresented Employee Groups of the City of Manteca who are not covered by a Memorandum of Understanding; and

WHEREAS, CalPERS requires that the City of Manteca adopt a resolution that specifically identifies the information for unrepresented employees in order to amend the contract with CalPERS to include cost share for the following employees:

- 1. Unrepresented employees covered by the Executive Management Compensation Plan and exempt-level Unrepresented Management-Confidential Employees' Unit Plan.
- 2. Employees who are CalPERS Classic Tier I, Classic Tier II and PEPRA members in the Executive Management Compensation Plan will cost share an additional 8% above the member contribution towards the employer rate per GC 20516(b).
- 3. Exempt-level employees who are CalPERS Classic Tier I, Classic Tier II and PEPRA members in the Unrepresented Management-Confidential Employees' Unit Plan will cost share an additional 5.75% above the member contribution towards the employer rate per GC 20516(b).
- 4. The effective date of this agreement will be as soon as is administratively possible by CalPERS.

WHEREAS, this resolution is in agreement between the City of Manteca and its unrepresented employees covered by the Executive Management Compensation Plan and Unrepresented Management-Confidential Employees' Compensation Plan to include cost share pursuant to GC 20516(b).

NOW THEREFORE, BE IT RESOLVED that the City Council of the City of Manteca at a public meeting of said City Council approves this Resolution to amend the existing contract between the City of Manteca and CalPERS under Government Code 20516(b).
