

1st AMENDMENT OF CONTRACT
BY AND BETWEEN CITY OF MANTECA
AND Bear Electrical Solutions, LLC

THIS 1st AMENDMENT ("Amendment") to the May 16, 2022 Agreement by and between the City of Manteca and Bear Electrical Solutions, LLC ("Agreement") is made and entered into this _____ day of _____, _____ by and between the CITY OF MANTECA, a municipal corporation of the State of California (hereinafter referred to as "CITY"), and Bear Electrical Solutions, LLC.

RECITALS:

A. WHEREAS, CITY and Bear Electrical Solutions, LLC entered into the Agreement on or around May 16, 2022, for the provision of Traffic Signal and Streetlight Maintenance Repair and related services; and

B. WHEREAS, the CITY and Bear Electrical Solutions, LLC desire to increase the compensation under the Agreement.

C. WHEREAS, Section 5. Amendments, Changes or Modifications of the Agreement allows the Parties to mutually agree to amend the Agreement in writing.

NOW, THEREFORE, in consideration of their mutual covenants, the parties hereto agree as follows:

AGREEMENT

1. **INCORPORATION OF RECITALS.** The recitals set forth above are hereby incorporated into this Amendment as if set forth herein in full.

2. **AMENDMENT.**

Section 3. Compensation, to the Agreement is hereby amended to read as follows: Compensation to be paid to Consultant shall be in accordance with the Payment Schedule set forth in Exhibit C, which is incorporated herein by reference. In addition to the Compensation for the Agreement, compensation for Amendment No. 1, shall in no event exceed \$775,000.00 (Seven Hundred Seventy Five Thousand Dollars and Zero Cents) without additional authorization from the City. In no event shall total compensation for work performed pursuant to this Agreement and Amendment No. 1 exceed \$2,425,000.00 (Two Million Four Hundred Twenty Five Thousand Dollars and Zero Cents) without additional authorization from the City.

3. **OTHER TERMS.** Except as expressly amended herein, the Agreement remains in full force and effect. Nothing in this Amendment shall be deemed to waive or modify

any of the other provisions of the Agreement. In the event of any conflict between this Amendment and the Agreement, the terms of this Amendment shall prevail.
