## FIRST AMENDMENT TO THE AGREEMENT FOR SOLID WASTE TRANSFER STATION SERVICES A-15-317 BETWEEN THE CITY OF MANTECA AND COUNTY OF SAN JOAQUIN

This First Amendment ("Amendment") to Agreement #A-15-317 ("Agreement"), is made and entered into this \_\_\_\_\_day of November, 2017, by and between the County of San Joaquin, a political subdivision of the State of California ("County") and the City of Manteca, a municipal corporation ("City").

## RECITALS

- A. On September 15, 2015, the City approved an Agreement with County to accept City's solid waste at the County's Lovelace Transfer Station.
- B. City desires to increase the maximum annual compensation limit from \$2.25 million to \$4 million to provide for the higher than anticipated waste streams.
- C. County and City now desire to amend the Agreement in order to increase the compensation limit.
- D. All other aspects of the Agreement remain the same.

NOW, THEREFORE, the parties hereby agree as follows:

- 1. Paragraph 4 <u>Compensation</u> of the Agreement is hereby amended to read as follows:
  - Without additional authorization from the City, compensation to be paid to County shall not exceed FOUR MILLION DOLLARS (\$4,000,000) per year. Payment by City under this Agreement shall not be deemed a waiver of any defects, even if those defects were known to the City at the time of payment.
- 2. Except as otherwise provided in this Amendment, the Agreement shall continue in full force and effect.
