RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING A BUDGET APPROPRIATION OF \$213,000 FROM THE GENERAL FUND FIRE MUTUAL AID REIMBURSEMENT REVENUE ACCOUNT AND AMEND THE FY25 CAPITAL IMPROVEMENT PROGRAM (CIP) FOR USED FIRE APPARATUS AND EQUIPMENT PROJECT (CIP NO. 24080)

WHEREAS, the City of Manteca Fire Department is committed to maintaining an efficient and effective emergency response fleet to serve the community and support regional mutual aid efforts; and

WHEREAS, the acquisition of used fire apparatus and equipment provides a cost-effective approach to enhancing the department's capabilities without incurring the high costs associated with new equipment; and

WHEREAS, the Used Fire Apparatus and Equipment Project (CIP No. 24080) was established in the City's Capital Improvement Program to support these types of acquisitions; and

WHEREAS, the Fire Department's ongoing participation in Long Term Mutual Aid (LTMA) deployments has resulted in increased revenue to the General Fund LTMA Revenue Account through state reimbursements; and

WHEREAS, sufficient funds are available in the General Fund Fire Mutual Aid Reimbursement Revenue Account to appropriate \$213,000 toward the acquisition of used fire apparatus and equipment; and

WHEREAS, the City Council desires to appropriate these funds to CIP No. 24080 and amend the Capital Improvement Program accordingly;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and they establish the factual basis for the City Council's adoption of this Resolution.
2. Approves a budget appropriation in the amount of \$213,000 from the General Fund Fire Mutual Aid Reimbursement Revenue Account to the General Fund Capital Outlay Vehicles Major expenditure account for project Used Fire Apparatus and Equipment (CIP No. 24080).
3. The City's Capital Improvement Program is hereby amended to reflect the increased project funding for CIP No. 24080 as specified above.

4. The City Council delegates to the City Manager the authority to execute any and all documentation and/or amendments in order to effectuate this Resolution.
5. This Resolution shall take effect immediately upon adoption.
