RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING HOMELESS HOUSING, ASSISTANCE AND PREVENTION (HHAP) PROGRAM – ROUND 4 GRANT FUNDS IN THE AMOUNTS OF \$196,951.73 FOR THE UNSHELTERED EMERGENCY CENTER AND \$61,062.00 FOR STREET OUTREACH; APPROVING BUDGET APPROPRIATIONS OF \$196,952 AND \$61,062 TO BOTH REVENUE AND EXPENDITURE ACCOUNT LINES IN FUND 141 ; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS

WHEREAS, the County of San Joaquin and the San Joaquin Continuum of Care (CoC) jointly released a Notice of Funding Availability (NOFA) in September 2024 for Round 4 of the State of California's Homeless Housing, Assistance and Prevention (HHAP) Program; and

WHEREAS, under this NOFA, the City of Manteca was awarded a total of \$258,013.73, consisting of \$196,951.73 for operational costs and services at the Unsheltered Emergency Center and \$61,062.00 for Street Outreach services; and

WHEREAS, these reimbursable grant funds will support the City's efforts to serve individuals experiencing homelessness and enhance service delivery at the emergency center located at 555 Industrial Park Drive; and

WHEREAS, to ensure financial transparency and compliance, Finance staff has established HUD Grants Fund 141 and recommends a budget appropriation from the General Fund (Fund 100) to Fund 141 in the amounts of \$196,952 and \$61,062.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
- 2. The City Council hereby accepts HHAP Round 4 grant funds in the amount of \$196,951.73 for the Unsheltered Emergency Center and \$61,062.00 for Street Outreach.
- The City Council approves a budget appropriation of \$196,952 and \$61,062 to both revenue and expenditure account lines in the HUD Grants (Fund 141).

- 3. The City Manager, or designee, is authorized to execute subrecipient agreements and all associated documents required to administer the HHAP Round 4 grant funds.
- This Resolution shall take effect immediately upon its adoption. 4.
