RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING A GRANT DEED FROM MICHAEL D. RANDALL AND NANCY S. RANDALL, TRUSTEES OF THE MICHAEL & NANCY RANDALL REVOCABLE LIVING TRUST FOR 4,345 SQUARE FEET OF REAL PROPERTY FOR RIGHT-OFWAY PURPOSES OVER A PORTION OF 2179 W. WOODWARD AVENUE (APN: 241-320-23)

WHEREAS, per a Condition of Approval for the Tentative Map for the Machado Ranch subdivision, the Developer is required to install frontage improvements along the W. Woodward Avenue frontage of 2179 W. Woodward Avenue including roadway paving, sidewalk, curb and gutter; and

Randall, Trustees of the Michael & Nancy Randall Revocable Living Trust for 4,345 square feet of real property for right-of-way purposes over a portion of 2179 W. Woodward Avenue (APN: 241-320-23) attached hereto as EXHIBIT A and incorporated herein by reference.
- 3. The City Clerk is hereby instructed to record this Resolution and the Grant Deed with the San Joaquin County Recorder's Office.
- 4. This Resolution shall take effect immediately upon adoption.
