RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, ACCEPTING A GRANT FROM THE STATE OF CALIFORNIA DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR THE GRANT ASSISTANCE PROGRAM FOR FISCAL YEAR 2024-2025

WHEREAS, the City of Manteca desires to undertake the Alcohol Policing Partnership Program (APP) administered by the State of California Department of Alcoholic Beverage Control (hereafter referred to as "ABC") in the amount of \$40,000 for the project term from October 1, 2024 through September 30, 2025; and

WHEREAS, the Police Department will use the grant to reduce the amount of calls at establishments and reduce the number of alcohol involved crimes through a combination of education, training, and enforcement; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
- Accept the grant from the State of California Department of Alcoholic Beverage Control ABC-OTS Grant Program, amend the Fiscal Year 2024-2025 Budget and appropriate funds as follows:
 - a) \$40,000 to Police Grants Funds State/County Alcoholic Beverage Control (Revenue Account No.150.00.00.900-4475.12)
 - b) \$39,500 to Police Grants Fund Salary, Overtime (Expense Account No. 150.11.00.200-5000.03)
 - c) \$500 to Police Grants Funds Supplies, ABC Sholder Tap (Expense Account No. 150.11.00.200-6210.18)
- The City Council agrees that the Chief of Police of the City of Manteca is authorized to execute on behalf of the City Council the grant application, including any extensions or amendments thereof and any subsequent contract with the State in relation thereto.

- 4. The City Council agrees that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and ABC disclaim responsibility for any such liability.
- 5. The City Council agrees that this award is not subject to local hiring freezes.
- 6. This Resolution shall take effect immediately upon its adoption.
