

RESOLUTION R2025-XXX

RESOLUTION ACCEPTING ALL IMPROVEMENTS FOR THE 2025 ANNUAL PAVEMENT MAINTENANCE PROJECT CIP ENG26001 (DIAMOND OAKS & CRIVELLO ESTATES, NORTH OF LOUISE AVE & EAST OF COTTAGE AVE) AS COMPLETE, AUTHORIZING THE CITY CLERK TO FILE THE NOTICE OF COMPLETION, AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO COMPLETE AND EXECUTE ALL ASSOCIATED DOCUMENTS, AND TAKE ALL APPROPRIATE ACTIONS NECESSARY TO CARRY OUT THE PURPOSE AND INTENT OF THE RESOLUTION.

WHEREAS, on July 30, 2025, City Council awarded the construction contract C2025-148 for the 2025 Annual Pavement Maintenance Project CIP ENG26001 (Project) to VSS International, Inc. (Contractor) for an amount of \$1,061,211. and approved a construction contingency of \$200,000 for a total project cost of \$1,261,211.; and

WHEREAS, the Project was constructed in general conformance with the conformed plans and specifications; and

WHEREAS, the Project included two change orders totaling \$8,825.83; and

WHEREAS, a summary of the change orders is as follows:

- Additional pavement crack seals and digouts identified in the field.
 - Additional microsurfacing and cape seal areas identified in the field.
 - Removal and replacement of additional sidewalk and striping.
- ;and

WHEREAS, the final project construction cost is \$1,070,036.83 and the Contractor has signed the final payment certification; and

WHEREAS, there is a 5% retention totaling \$53,501.85 that will be released to the Contractor no sooner than 45 days after filing the Notice of Completion at County Recorder's Office; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City

2. The City Council hereby accepts all improvements for the 2025 Annual Pavement Maintenance Project CIP ENG26001 (Diamond Oaks & Crivello Estates area, north of Louise Ave & east of Cottage Ave) as complete.
3. The City Council hereby authorizes the City Clerk to file the Notice of Completion.
4. The City Council hereby authorizes the City Manager or designee to complete and execute all associated documents and take all appropriate actions necessary to carry out the purpose and intent of this resolution.
5. This Resolution shall take effect immediately upon its adoption.
