AMENDMENT NO. 1 TO THE AGREEMENT FOR SERVICES BETWEEN THE CITY OF MANTECA AND TRC ENGINEERS, INC.

RECITALS

- A. On January 21, 2025, the City of Manteca approved an Agreement with Consultant to provide professional services for construction management and inspection services for the Main Street (Northgate Dr to Alameda St) Bike and Pedestrian Improvement Project CIP 20005 HSIPL 5242(035).
- B. City now desires to amend the Agreement in order to expand the scope of services to be undertaken by the Consultant.
- C. Consultant represents that it has the necessary professional skills and experience to satisfactorily provide consulting services in a timely manner.
- D. City desires to engage Consultant for the purposes of completing the scope of services identified.

NOW, THEREFORE, the parties hereby agree as follows:

- 1. <u>Statement of Work.</u> Exhibit A to the Agreement is hereby amended by adding the tasks set forth in Attachment 1 to this Amendment, attached hereto and incorporated herein by reference, "Statement of Work and Activities #2".
- 2. Paragraph 3 of the Agreement is hereby amended to read as follows:
 - "3. <u>Compensation</u>. Compensation to be paid to Consultant shall be in accordance with the Schedule of Charges set forth in Attachment 1, which is incorporated herein by reference. In addition to the Compensation for the Agreement, compensation for Amendment No. 1 services shall in no event exceed SEVENTY TWO THOUSAND TWO HUNDRED NINETY SEVEN DOLLARS AND TWELVE CENTS (\$72,297.12) without additional authorization from the City. In no event shall total compensation for work performed pursuant to this Agreement and Amendment No. 1 exceed TWO HUNDRED FIFTY SIX THOUSAND TWO HUNDRED NINETY SEVEN DOLLARS AND TWELVE CENTS (\$256,297.12) without additional authorization from the City. Payment by City under this Agreement shall not be

- deemed a waiver of defects, even if such defects were known to the City at the time of payment."
- 4. Except as otherwise provided in this Amendment, the Agreement shall continue in full force and effect.
