RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE A RENEWAL LETTER EXERCISING THE CITY'S OPTION TO CONTINUE PARTICIPATION IN THE SAN JOAQUIN URBAN COUNTY PROGRAM FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND HOME INVESTMENT PARTNERSHIPS (HOME) PROGRAMS THROUGH FISCAL YEARS 2026–2028

WHEREAS, the City of Manteca entered into a Cooperation Agreement with the County of San Joaquin in July 1993 to participate in the Urban County Designation Program administered by the United States Department of Housing and Urban Development (HUD); and

WHEREAS, participation in the Urban County Designation Program allows the City to receive Community Development Block Grant (CDBG) and Home Investment Partnerships (HOME) funding through the County of San Joaquin; and

WHEREAS, execution of a cooperation agreement between participating jurisdictions is required by HUD as a condition of participation in these federal programs; and

WHEREAS, the City Council previously exercised renewal options to continue participation in the Urban County Program in July 2002, August 2004, June 2008, June 2011, June 2014, June 2017, June 2020, and June 2023; and

WHEREAS, the current participation period is scheduled to expire in September 2026; and

WHEREAS, the Cooperation Agreement contains a provision allowing participating jurisdictions to renew their participation for an additional three-year period through written notification to the County of San Joaquin; and

WHEREAS, continued participation in the Urban County Program ensures the City remains eligible to receive annual allocations of CDBG and HOME funding, subject to Congressional appropriations, for the benefit of low- and moderate-income residents and local public service agencies; and

WHEREAS, failure to continue participation would require the City to compete for federal funding through a national competitive process, creating uncertainty in funding availability and increasing administrative burdens.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

1. The City Council hereby authorizes the City Manager to execute and submit a renewal letter to the County of San Joaquin exercising the City's option to continue participation in the Urban County Designation Program for the Community Development Block Grant (CDBG) and Home Investment Partnerships (HOME) Programs through Fiscal Years 2026–2028.
2. The City Manager is authorized to take all actions necessary and appropriate to implement this Resolution and continue the City's participation in the Urban County Program.
3. This Resolution shall take effect immediately upon its adoption.
