### Recommendation:

Approve Agreement with Satellite Housing Inc. for transfer of property located at 282 N. Airport Way to the Redevelopment Agency.

## Background:

On December 4, 2006, the Redevelopment Agency approved assistance in the form of a \$1.5 million Conditional Grant to Satellite Housing, Inc. for acquisition of property and pre-development costs related to the development of an affordable apartment complex located at 282 N. Airport Way.

Due to several variables, the affordable apartment complex was not developed, and Satellite Housing Inc. has been holding the land. The Grant Agreement stated that Satellite would seek a subdivision of the property to divide it into the First Phase and Second Phase in a reasonably timely manner ("Grant Agreement" Grant Requirements 3.1).

Satellite Housing Inc. approached the Agency and proposed that the Agency accept title to the property and cancel the loan/debt. Agency staff is recommending the Agency Board agree to approve the transfer of property (on the terms and subject to the conditions set forth in the "Agreement for Transfer of Property").

#### Fiscal Impact:

Because this loan was originally structured to be a "forgivable loan" based on the development of the project, the Agency will not be losing any revenue as a result of receiving this property. Sufficient funds are

available in Account No. 215-5115-602-13-05 to cover the title insurance costs and miscellaneous fees associated with the land transfer, estimated to be \$5,000.


